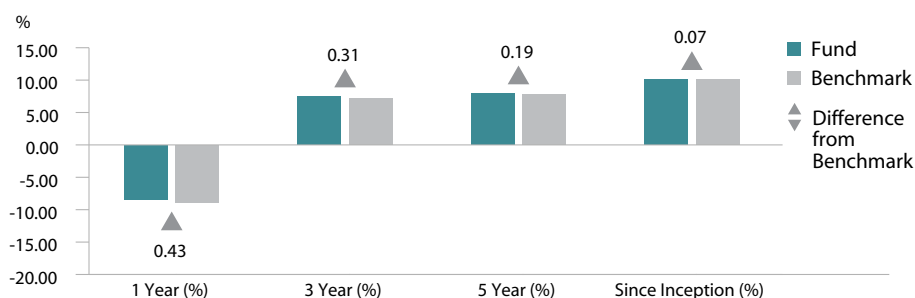

Previous to 19 November 2020, the Fund was known as All World Equity Index Sub-Fund, tracking the FTSE® All World Index.

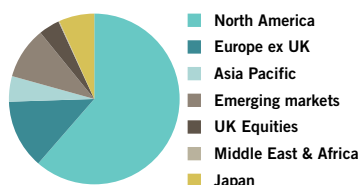
